Did You Know?

A power-assisted bicycle, also called an electric bicycle or e-bike, is a bicycle with an electric motor that has:

(a) A handlebar for steering,

(b) Working pedals,

(c)Two or three wheels,

(d)An electric motor, and

(e)Braking systems

E-bikes must meet certain requirements to be legally operated on roads in Ontario. This includes weight and speed limits.

When riding an e-bike, you must:

(a)Be 16 or older,

(b)Wear an approved bicycle or motorcycle helmet,

(c)Keep your e-bike in good working order, and

(d)Follow the same rules of the road as other cyclists.

For everyone's safety, please be advised that the Ontario Traffic Act is enforced on Mississauga First Nation Territory. Safety is our number one priority for all Band Members and those in attendance for extracurricular activities hosted on the First Nation.

Public Notice

With summer upon us MFN wishes to remind **ALL MFN Band members** that should they wish to invite Non-Native\Non-Treaty guests to fish and hunt on MFN land, that a Permit from the Lands Department is required.

All unpermitted fish and wildlife harvesting will be treated as **Trespassing**, with or without the band members consent and could result in further legal action.

MFN lands department has installed an operational permitting system and is implementing it on MFN lands for the purpose of safeguarding the resources that sustain our way of life. And will continue to for the next seven generations.

All Non-Native\Non-Treaty, and guests are required to obtain a permit should they wish to fish and hunt on MFN lands.

No Inter treaty harvesting is permitted on MFN lands.

Only Shipman letters authorized by Chief and Council will be recognized All others permit applications require a valid Ontario fishing or hunting license.

Fishing permit cost

January - June = \$100

July - Dec =\$100

Full year = \$200

<u>Hunting & Fishing 1 year</u> - \$300 includes small game and deer ONLY (Moose and Bear harvesting is not permitted)


Mature Bulls and Dry Cows ONLY!! - In ideal situations these are the best options for harvest. These animals should be selected for harvest as they provide the largest portions of meat per family, and can be spread around our community without having to harvest the most vulnerable section of their population.

NO COWS AND CALVES!!! - Cow and calf hunting can impact the ability to harvest these relatives in the years to come. We want to ensure that the reproductive cycles of the moose population continue to be sustainable for future generations of harvesters.
