

Indigenous Archaeological Monitoring Training Opportunity



Hydro One, in collaboration with Waasmoowin Energy Inc., are proud to offer **Indigenous Archaeological Monitor training opportunities** for interested Partner band members.

The training program will be offered by archaeologists Sarah Hazell, an Anishnawbe Kwe from Nipissing First Nation, and Jake Cousineau. The training is designed to offer foundational modules in archaeology enabling participants to apply for monitoring and technician positions for stage 2 archaeological assessments for both the Northeast Power Line and Northshore Link projects.

Training will involve 5 days in classroom on the basics of archaeological techniques, and one day for field training in the methodology of archaeological survey. Training will be offered at Mississauga First Nation, in Blind River from September 16-21.

What will you learn:

- Introduction to archaeology
- Identification of artifacts and bones
- Ontario archaeological legislation and Ministry of Citizenship and Multiculturism's Standards and Guidelines for Consultant Archaeologists
- Indigenous occupation of Ontario and more

Qualifications:

No experience is required, however interest in cultural heritage, the outdoors and archaeology are essential.

- MFN has two Needle drop boxes in 2 locations within the community 1) Near the community center and 2) near the tennis courts down the hill.
- Harm reduction supplies (clean needles/pipes) can be picked up at the clinic.
- Naloxone kits and training can be done at the clinic.
- Needle exchange program at the clinic, bring in your full Sharps container and we will give you a new one.

Blastomycosis is a fungus found in the soil and rotten wood near lakes and rivers, try to avoid these areas if you are immunocompromised, avoid over turning and playing in soil near these areas.


West Nile symptoms:
